# COMPANY BACKGROUND

# WHO WE ARE

The National Conservation Trust Fund of Jamaica (NCTFJ) Limited is a nonprofit organisation established in 2014.

#### WHAT WE DO

The organisation's purpose is to fund activities that are related to the conservation and management of a protected area or areas of environmental significance and fund activities that contribute to the long-term sustainability of Jamaica's National Protected Areas System.

The establishment of the organisation was a significant output of the Government of Jamaica/Global Environment Facility strengthening the Operational and Financial Sustainability of the National Protected Areas System Project and the NCTFJ is guided by the Protected Areas System Master Plan (PASMP) that was approved by Cabinet in 2017. The PASMP consists of the strategies, actions and priority areas for effectively managing protected areas.

As a partner of the Caribbean biodiversity community, the NCTFJ is linked to and receives funding support from the Caribbean Biodiversity Fund (CBF), a US\$42M endowment facility, with subaccounts for nine countries in the Caribbean. The NCTFJ signed a Partnership Agreement with the CBF on World Environment Day – June 5th, 2019. In December 2020, the NCTFJ used the funding received from the CBF to launch its first Call for Proposals, funding two projects that would directly impact two Protected Areas.

# **BOARD OF DIRECTORS**

The NCTFJ has an active multi-stakeholder Board of Directors which serves as a fiduciary body. The Board of Directors comprises eleven members, including representatives from the Government of Jamaica, the private sector and civil society.

The Government entities are represented by one member each from the Ministry with responsibility for the Environment, the Ministry with responsibility for Finance, the Planning Institute of Jamaica and the Tourism Enhancement Fund. The private sector and civil society representatives include two non-government organizations involved in protected areas management, one representative each from the tourism and financial sectors, one representative from a tertiary academic institution, and two citizens-at-large, (one being an attorney-at-law). The Chair of the Board is selected from the non-government Directors.



# Lisa Grant // Chair

Lisa Grant is an attorney-at-law with twenty years of experience at the Jamaican bar. She also holds a Bachelor of Arts degree in History and Politics from the University of the West Indies and a Master of Laws degree in Comparative Law from McGill University

where she studied International Trade Law and Intellectual Property Law. Ms. Grant worked with the Jamaica National Heritage Trust for twelve years in the capacity of Legal Officer and Director of Heritage Protection, Research and Information during which time she represented that agency on the Protected Areas Committee which directed the preparation of the Protected Areas System Master Plan for Jamaica. She has also studied Ocean Governance: law, policy and regulation at Dalhousie University in Halifax, Canada and received a Diploma from the International Tribunal for the Law of the Sea in Hamburg, Germany being one of seven selected recipients of a Nippon Fellowship. She has the distinction of being the first Jamaican participant in that programme. She served as Counsel to the Bureau of Standards Jamaica for four years prior to her appointment to Technological Solutions Limited in 2019.

Ms. Grant also serves on the boards of the Holy Childhood Preparatory School and St. Richard's Primary School. She formerly held the post of Vice Chair of the NCTFJ.



#### Matthew Wallace // Vice-Chair

Matthew Wallace is the owner of Matthew's Restaurant in Negril, Jamaica. His family's deep roots in the hospitality industry prepared a path for him in the field of business. He attended Florida International University where he had his first taste for a passion for culinary arts, graduating with a Bachelor of Science in

Hospitality Management. He worked as Front Office Manager with Marriott in Florida, but his heart always belonged in Jamaica. With his newfound knowledge and experience, he moved back to Jamaica and became the General Manager of the Jungle Night Club in Negril. While managing the club at night Matthew became a farmer by day, rearing livestock as well as growing crops. He continued on his fiery path co-founding Scotch Boyz Jamaica Ltd. and was appointed CEO. # **Suzanne Shaw**



# **IN REVIEW**

# **Grant-Making Programme**



The National Conservation Trust Fund of Jamaica (NCTFJ) launched its second Call for Proposals on May 19, 2021. The two-step application process includes (i) the submission of Concept Notes, and (ii) requesting the applicants with exceptional Concept Notes to submit full proposals.

The Call welcomed Concept Notes for projects and programmes that will support Nature-based Solutions (NBS) for economic recovery in protected areas. The Call for Proposals focused on:

- 1. Management and protection of protected areas
- 2. Restoration and/or Rehabilitation of ecosystems

The Call closed on June 22, 2021. Seven applicants were shortlisted and invited to submit Full Proposals. Each shortlisted applicant was provided with one-on-one coaching for the preparation of their proposal. The deadline for the submission of Full Proposals was August 26, 2021.

On December 6, 2021, the NCTFJ signed Grant Agreements valued at approximately J\$ 20 million with six entities. The distribution of funds is given in Table 1 on the next page.

All projects were in response to the theme "Nature-based Solutions (NBS) for economic recovery in protected areas". The projects include coral reef restoration, water quality assessment, improving livelihood protection and resilience, marine education and eco-tourism. The areas that will benefit include the Portland Bight Protected Area, Discovery Bay Marine Protected Area, White River Fish Sanctuary, Oracabessa Bay Marine Protected Area, Orange Bay Special Fishery Conservation Area, Boscobel Special Fishery Conservation Area, East Portland Fish Sanctuary, Bogue Islands Lagoon and Montego Bay Point Fish Sanctuaries.

### Highlight of Grants awarded in 2020

During the reporting period, there were ongoing projects which began officially in 2020. A summary of the activities taking place is presented in the tables on the next page:

# **Caribbean Conservation Finance Congress**



The inaugural Caribbean Conservation Finance Congress was hosted by the Caribbean Biodiversity Fund and the Saint Lucia National Conservation Fund from July 6th – 8th, 2021 in a virtual format. The Congress focused on building and showcasing Caribbean sustainable financing solutions for conservation and sustainable development, exchanging experiences among Caribbean actors, and learning from other regional and global initiatives.

# Caribbean Conservation Finance Congress (Cont'd)

#### The objectives of the CCFC were:

- 1.To discuss and advance conservation finance mechanisms designed by the Caribbean for the Caribbean.
- 2.To promote strong and long-term financing solutions and resource mobilization scenarios for the Caribbean region to accomplish the 2030 targets, including positioning the Caribbean Sustainable Finance Architecture and conservation trust funds in general as key allies for resource mobilization.

The NCTFJ participated in the congress and the NCTFJ Fund Manager was the moderator for the session that addressed Small Island Developing States (SIDS) 2030 Agenda for Sustainable Development and Resources Mobilization. This session analyzed the resource mobilization needs for SIDS and the Caribbean region, in particular, to mobilize the necessary resources to achieve the 2030 Agenda for Sustainable Development.

# **Capacity Building**

# Proposal Writing & Project Development Workshops

After a careful review of the NCTFJ's inaugural call for proposals, the NCTFJ acknowledged that it was necessary to provide additional support to strengthen the technical capacity of potential grantees. The partnered with Business Development Corporation (JBDC) to provide potential NCTFJ grantees with the necessary tools and knowledge needed to develop and modify bankable proposals that protected will support areas management.





NCTFJ will be providing support in proposal writing and project development to interested applicants for NCTFJ's 2nd Call for Proposals.

This was delivered via a virtual workshop series to participants to assist with concept notes and proposal writing, using the NCTFJ template as a guide. The workshop was held over four sessions; two in Concept Note Development in June 2021 and two in Proposal Development in July 2021. A total of forty-two people attended the workshops. The attendees included representatives from Environmental Non-Government Organizations, Community Based Organizations, the Private Sector and Public Sector. Participants who attended at least three workshops received their certificates and all participants received the training materials.

# **Monitoring & Evaluation Workshops**

The partnership with JBDC included training workshops that focused on monitoring and evaluation. These workshops were conducted for the NCTFJ staff, to strengthen the organisation's capacity to effectively monitor and evaluate all funded NCTFJ programmes and projects. The workshops were held in two sessions in July 2021.

The NCTFJ will use the knowledge gained to guide the preparation of the organisation's monitoring and evaluation plan.

# **Resource Mobilisation**

# Mobilizing payment 2 from Caribbean Biodiversity Fund

On April 19, 2021, the NCTFJ successfully mobilized US\$249,754.21 as its second payment from the CBF. This funding will be used to fund the six projects that support protected areas management, monitoring and evaluation of projects, meetings and events to promote coordination among protected areas agencies, outreach activities, capacity building and administrative expenses.

# **Grant Agreement with Inter-American Foundation**

On August 13, 2021, the NCTFJ signed a three-year Grant Agreement with the Inter-American Foundation (IAF). Under this Agreement the NCTFJ will receive a total of US\$340,445. With these resources, the NCTFJ will fund environmentally based, community development projects that strengthen community organizations and encourage private social investment in Jamaica. Additionally, the project will assist the NCTFJ in strengthening its communications and fundraising capacity.
